- (a) Loss or damage arising from War, War like operations, Civil Commotion, Terrorism, Depreciation, wear and tear, moth, mildew, vermin, the process of cleaning, dyeing, repairing, overwinding of clocks and watches, mechanical derangement, electrical breakdown, breakage of glass, china and articles of brittle nature, theft from unattended vehicles, detention or confiscation by Customs or other Authorities and consequential loss.
- (b) Money, Securities, Manuscripts, Deeds, Bonds, Bills of Exchange, Promissory Notes, Stock or Share Certificates, Stamps, Business Books and documents, articles dispatched under contract of affreightment
